WHEREAS, we, THOMAS M.B. ROBERTS, TIMOTHY M. HOPKINS and QUINTON A. QUINTANA, have invented certain new and useful improvements in and for SURGICAL STAPLING INSTRUMENT HAVING A TWO-POSITION LOCKOUT MECHANISM and for which we have executed application papers for the United States Letters Patent thereon.
