## ASSIGNMENT

- e. any and all claims and causes of action, with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation. Assignor hereby authorizes the Commissioner for Patents and the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Assignment upon request by Assignee.

3. Endorsement. Assignor hereby agrees to endorse and deliver to Assignee, without recourse and without representation or warranty of any kind, said assets as described herein, at the time of execution and delivery of this Assignment.


4. Binding Assignment. This Assignment inures to the benefit of, and is binding upon, the respective parties hereto, their successors and assigns.
