Pursuant to Section 264(c) of the General Corporation Law of the State of Delaware, Biggie Inc., a Delaware corporation (the “**Corporation**”), hereby certifies as follows:

FIRST: The name and state of incorporation of each of the Corporation and Loud & Clear Products, LLC, a California limited liability company (“**LCP**”), which are the constituent entities in the merger (the “**Constituent Entities**”), are as follows:

SECOND: The Agreement and Plan of Merger and Reincorporation dated as of October 23, 2019 (the “**Merger Agreement**”) by and between the Constituent Entities has been approved, adopted, certified, executed and acknowledged by each of the Constituent Entities in accordance with the requirements of Section 264 of the General Corporation Law of the State of Delaware.

THIRD: The merger shall become effective at the time of the filing of this Certificate of Merger with the Secretary of State of the State of Delaware (the “**Effective Time**”).

FOURTH: In accordance with the Merger Agreement, at the Effective Time, LCP will merge with and into the Corporation, and the Corporation will continue as the surviving corporation (the “**Surviving Corporation**”). At the Effective Time, the separate existence of LCP will cease.

FIFTH: The name of the Surviving Corporation of the merger is Biggie Inc.

SIXTH: The Certificate of Incorporation of the Surviving Corporation shall be the Amended and Restated Certificate of Incorporation of the Corporation attached as Exhibit A being concurrently filed.

SEVENTH: The executed Merger Agreement is on file at an office of the Surviving Corporation, the address of which is 786 Maysville Circle, Thousand Oaks, CA 91360.

EIGHTH: A copy of the Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder or member, as applicable, of either Constituent Entity.
