Under Section 803 of the Not-for-Profit Corporation Law


The undersigned, Kevin J. Tracey, M.D., being the President of The Feinstein Institute for Medical Research, does hereby certify:

1. The name of the corporation is The Feinstein Institute for Medical Research (the "Corporation"). The Corporation was formed under the name "North Shore University Hospital Research Corporation."
2. The Certificate of Incorporation was filed by the Department of State on December 1, 1983.
3. The Corporation was formed as a type B corporation under Section 201 of the Not-for-Profit Corporation Law.
4. The Corporation is a corporation as defined in subparagraph (5) of paragraph (a) of Section 102 of the Not-for-Profit Corporation Law and is a charitable corporation under Section 201 of the Not-for-Profit Corporation Law, and shall remain a charitable corporation after the filing of this Certificate of Amendment.
5. The Certificate of Incorporation of the Corporation is hereby amended to change the name of the Corporation to The Feinstein Institutes for Medical Research.
6. To effectuate the amendment described in Paragraph 5 of this Certificate of Amendment, Paragraph FIRST of the Certificate of Incorporation is hereby amended to read in its entirety as follows:  
  
FIRST: The name of the Corporation is The Feinstein Institutes for Medical Research (the "Corporation").
7. The Secretary of State is designated as agent of the corporation upon whom against it may be served. The address to which the Secretary of State shall forward copies of process accepted on behalf of the Corporation is 350 Community Drive, Manhasset, New York 11030, Attention: Administration.
8. This amendment to the Certificate of Incorporation was authorized by the unanimous written consent of the sole member of the Corporation.
