AND WHEREAS the Assignee is desirous of acquiring full and exclusive rights in said Registered Designs, Registered Trade Marks and Patents;


NOW THEREFORE in consideration of the sum of £1 to be paid by the Assignee to the Assignor, the Assignor DOES HEREBY:


