the Assignor agrees to do all lawful acts and to execute and deliver, without further consideration, all further documents as may reasonably be required by the Assignee, or by its successors, assigns, nominees, or other legal representatives, to obtain said patents in the United States for the Invention and vest or secure the same in the Assignee, and in the Assignee's successors, assigns, nominees or other legal representatives; and

the Assignor grant to said Assignee, its successors, assigns, nominees or other legal representatives, including its patent agent **NORTON ROSE FULBRIGHT CANADA LLP/S.E.N.C.R.L., s.r.l.**, the power to insert on this Confirmatory Assignment any further information which may be necessary or desirable in order to comply with statutory requirements for recordation of this document.
