PATENT ASSIGNMENT

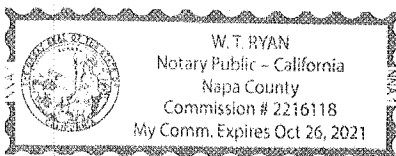


