THIS ASSIGNMENT AGREEMENT EFFECTIVE AS OF THE 16th day of August, 2019.





NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other valuable consideration, the receipt of which is hereby acknowledged,


