We also hereby authorize and request the Commissioner of Patents and Trademarks to issue any and all Letters Patent of the United States and any foreign patent offices on said invention or resulting from said application and from any and all additional provisionals, non-provisionals, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations, post-grant proceeding, derivations, or other inter-parties review proceedings thereof, to Assignee, as assignee of our entire interest, and hereby covenant that we have the full


right to convey the entire interest herein assigned, and that we have not executed and will not execute any agreement in conflict herewith.

We still further covenant and agree that we will, at any time upon request, communicate to Assignee or its successors, assigns, or other legal representatives, such facts relating to said invention and Letters Patent or the file history thereof as may be known to us, and testify as to the same in any interference, litigation, or other proceeding when requested so to do, without further compensation but at the expense of Assignee or its successors, assigns, or other legal representatives.


