IP TRANSFER AGREEMENT

between

DIGITAL TRANSACTION LIMITED

and

ETERNAL PARADISE LIMITED

THIS IP TRANSFER AGREEMENT ("Agreement") is dated 20 May 2020 ("Effective Date")

BETWEEN

- (1) **DIGITAL TRANSACTION LIMITED**, a company incorporated in Hong Kong, having its registered office at 26th floor, Three Exchange Square, 8 Connaught Place, Central, Hong Kong ("Transferor"); and
- (2) **ETERNAL PARADISE LIMITED**, a company (registered no. 217156) incorporated in the Republic of Seychelles, having its registered office at Global Gateway 8, Rue De La Perle, Providence, Mahé, Republic of Seychelles ("Transferee").

WHEREAS:

- A. The Transferor is the applicant of the Patent Applications [REDACTED] as defined below.
- B. The Transferor has agreed to transfer to the Transferee the Patent Applications [REDACTED] together with all the rights, title and interest therein upon the terms and conditions set out below.

NOW IT IS HEREBY AGREED as follows:

1 Definitions and Interpretation

- 1.1 In this Agreement, the following terms shall have the defined meanings below unless the context otherwise requires:

"Transferred Applications", "Corresponding Application", "Divisional Application", "Extended Application" and "Granted Patents" shall have the respective meaning given to them in Clause 2.1.

"Hong Kong" means the Hong Kong Special Administrative Region of the People's Republic of China.

"Intellectual Property" means patents, utility models, rights to inventions, copyright and related rights, trademarks and service marks, business names and domain names, rights in get-up, goodwill and the right to sue for passing off, rights in designs, database rights, rights to use and protect the confidentiality of confidential information including know-how and trade secrets, and all other intellectual property rights whether registered or unregistered, including all applications and rights to apply for and be granted, renewals or extensions of, and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection which subsists in any part of the world.

"Patent Applications" means the patent applications listed under Schedule 1.

2 Transfer of Patent Applications

2.1 Transferor hereby assigns to Assignee all its right, title and interest in and to the Patent Applications, and in and to all and any inventions disclosed in the Patent Applications, including:

(a) the right to file an application, claim priority from any of the Patent Applications, in or in respect of any country or territory in the world or before a regional patent office or WIPO ("**Corresponding Application**");

(b) the right to file a divisional application, continuation application, continuation-in-part application, or any similar follow-up application, in or in respect of any country or territory in the world or before a regional patent office or WIPO, arising from or based on any of the Patent Applications or Corresponding Application ("**Divisional Application**")

(c) the right to extend any of the Patent Applications, Corresponding Application or Divisional Application to, or register any of the Patent Applications, Corresponding Application or Divisional Application in or in respect of any country or territory in the world ("**Extended Application**", together with the Patent Applications, Corresponding Application and Divisional Application, collectively "**Transferred Applications**");

(d) the right to prosecute and obtain grant of patent or similar protection from the Assigned Applications, and the absolute entitlement to any patents granted from the Assigned Applications ("**Granted Patents**"); and

(e) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of any of the Assigned Applications or any Granted Patents, whether the infringement or such other cause of action occurs before, on or after the date of this Agreement.
