NUNC PRO TUNC ASSIGNMENT

WHEREAS, **Kronoplus Limited**, a corporation organized and existing under the laws of the Republic of Cyprus, having a place of business at Grayoak House, 9 Tagmatarchou Poulidou Street, 1101 Ayios Andreas, Nicosia, Cyprus, ("Assignor"), has by virtue of assignment, received right, title and interest to a certain invention or inventions ("Invention or Inventions") related to the invention described in the following patent application (hereafter "Patent"):

The International Patent Application PCT/EP2016/082594, filed December 23, 2016, entitled PANELS IMITATING ORGANIC WOOD PLANKS COMPRISING SPECIALLY DECORATED EDGES;

NOW, THEREFORE, in consideration of valuable and legally sufficient consideration, the receipt of which by the Assignor from the Assignee is acknowledged, the Assignor has sold, assigned and transferred, and by these presents sell, assign and transfer to the Assignee, the entire right, title and interest for the United States and for countries foreign to the United States in the Invention or Inventions and the Patent identified above, and any patents that may issue for the Invention or Inventions in the United States and in countries foreign to the United States, including the full right to claim for any such application all benefits and priority rights under any applicable convention; with the entire right, title and interest in all continuations, divisions, renewals and extensions of any of the patent applications and patents defined above; with the right to recover all damages, including, but not limited to, a reasonable royalty, by reason of past, present, or future infringement or any other violation of patent or patent application rights; to have hold for the sole and exclusive use and benefit of the Assignee, its successors and assigns, to the full end

of the term or terms for all such patents. The Assignor sells, assigns and transfers the entire right, title and interest to the Assignee as of the day of execution of this Assignment.


The Assignor hereby consents that a copy of this Assignment shall be deemed a full legal and formal equivalent of any document that may be required in any country in proof of the right of the Assignee to apply for patent or other form of protection for the Invention or Inventions and to claim the aforesaid benefit of the right of priority.

The Assignor requests that any and all patents for the Invention or Inventions be issued to the Assignee in the United States and in all countries foreign to the United States or to such nominees as Assignee may designate.

The Assignor agrees that, when requested, the Assignor shall, without charge to the Assignee, but at its expense, sign all papers, take all rightful oaths, and do all acts that may be necessary, desirable or convenient in connection with said applications, patents, or other forms of protection for the Invention or Inventions.


