Whereas:

1. Assignment

- (iii) the right to file and prosecute divisional applications, continuations and continuations-in-part of all National Applications (the '**Divisional Applications**'); and
 - (iv) the absolute entitlement to any patents granted pursuant to all National Applications and Divisional Applications for their full period, including any re-issues, re-examinations, renewals, extensions and Supplementary Protection Certificates; and
- (b) The right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of the Invention, the Patents and any patents granted on any of the applications filed as aforesaid in sub-clause (a), whether occurring before, on or after the date of this Assignment.

2. Further assurance

At the Assignee's expense, each of the Inventors will promptly execute and deliver such documents and perform such acts as may be required for the purpose of giving full effect to this Assignment.

3. Counterparts


This Assignment may be executed in any number of counterparts, each of which when executed will constitute a duplicate original, but all the counterparts will together constitute the one Assignment.

This Assignment is governed by the law of England and Wales and subject to the non-exclusive jurisdiction of its courts.




