
AND Assignor hereby represents, warrants and covenants that Assignor has the full right to convey the interest herein assigned, that Assignor has not executed and will not execute any



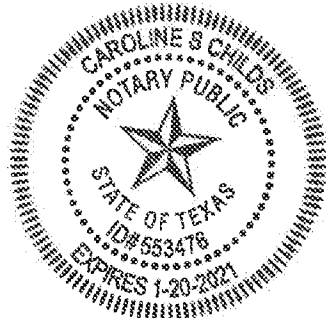
