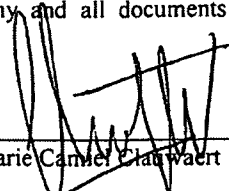

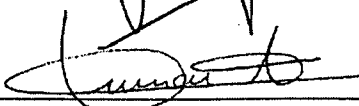

including the prosecution thereof, and to execute any and all documents necessary to vest title said foreign applications and patents in said assignee.

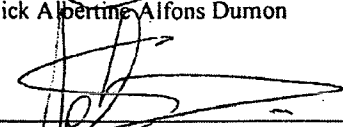

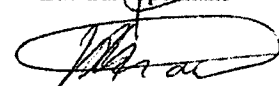
