ASSIGNMENT

WHEREAS, **J. 
NOW, THEREFORE, for and in consideration of One Dollar (\$1.00), and other good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR hereby sells and transfers to said Georgetown, and to Georgetown’s successors and assigns, ASSIGNOR’S entire right, title and interest in and to said inventions and discoveries in the United States and its territorial possessions and in all foreign countries and to all Letters Patent or similar legal protection in the United States and its territorial possessions and in any and all foreign countries to be obtained for said inventions and discoveries by said application or any patent application claiming priority to the application, or any continuation, division, continuation-in-part, reexamination, renewal, substitute, extension or reissue thereof or any legal equivalent thereof in a foreign country for the full term of terms for which the same may be granted; and authorize and request the Commissioner of Patents of the United States and any official of any foreign country whose duty it is to issue patents or legal equivalents thereto, to issue same for this inventions and discoveries to Georgetown, its lawful successors and assigns.

ASSIGNOR further covenants that Georgetown will, upon its request, be provided promptly with all pertinent facts and documents relating to said application, said inventions and discoveries and said Letters Patent and legal equivalents in foreign countries as may be known and accessible to ASSIGNOR and will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to Georgetown or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said application, said inventions and discoveries and said Letters Patent and said equivalents thereof in any foreign country which may be necessary or desirable to carry out the purposes thereof.
