WHEREAS I, Peter Robert William PUGH, acknowledges that all rights in said Invention and improvements thereto and the right to file patent applications therefor in any and all countries of the world and to any and all patent applications therefor and any Letters Patent which may be issued thereupon in any and all countries of the world have vested in BP OIL UK LIMITED, by contract of employment or through application of law; and

WHEREAS by an assignment dated 21st March 2016 BP p.l.c. and BP OIL UK LIMITED have assigned any and all rights, title and interest of BP p.l.c. and BP OIL UK LIMITED in said Invention to AIR BP LIMITED and AIR BP LIMITED has accepted the assignment; and

WHEREAS it is the wish of all the parties that the entire right, title and interest in, to and under the said Invention and any improvements thereon and the right to file patent applications therefor in any and all countries of the world any, and all patent applications therefor in the USA and all other countries of the world, and any and all Letters Patent which may be issued thereupon in the USA and all other countries of the world, shall vest solely in said AIR BP LIMITED having a registered office at Chertsey Road, Sunbury on Thames, Middlesex, TW16 7BP, United Kingdom; and being registered in England and Wales with company number 01150609
