## V. Preliminary Statement:

A. I-Tek and Oak have been cooperating to develop a door lock related invention (the "Door Lock Invention") that is disclosed in the Oak Patent Applications and the I-Tek Patent Applications. Inventors from both I-Tek and Oak have made inventive contributions to the Door Lock Invention.

- B. I-Tek filed the I-Tek Patent Application listing inventors associated with I-Tek, and acquired ownership of the I-Tek Patent Application through an assignment of the inventor's rights to I-Tek.
- C. Oak filed the Oak Patent Applications listing inventors associated with Oak, and acquired ownership of the Oak Patent Applications through an assignment of the inventors' rights to Oak.
- D. I-Tek and Oak may, if appropriate file other applications directed to the Door Lock Invention.
- E. After reviewing the facts related to the invention of the Door Lock Invention, the Parties have come to believe that:
  - a. It may well be appropriate for the Inventors currently listed on the Oak Patent Application to be listed as inventors on the I-Tek Patent Application;
  - b. It may well be appropriate for the Inventor currently listed on the I-Tek Patent Application to be listed as an inventor on the Oak Patent Applications; and
  - c. It may well be appropriate for all or some combination of the currently listed inventors on the I-Tek and Oak Patent Applications to be listed as Inventors on subsequently filed Door Lock Invention Related Patent Applications.


Trademarks is hereby authorized and requested to issue and Reissue the Letters Patent, to the Assignee, its successors and assigns, in accordance with this Assignment.

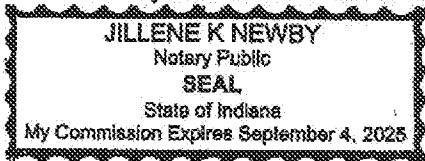
