Assignor also assigns to Assignee, all right, title and interest in, and to all, inventions and improvements which are the subject of, and disclosed in, the Patents throughout the world, including all priority applications, counterpart international, national, and regional stage applications and patents; the right to file applications and obtain patents, utility models, industrial models, and designs based on the Patents or applications therefor in its own name throughout the world, including all rights to claim priority based on the filing dates of the Patents under the International Convention for the protection of Industrial Property, the Patent Cooperation Treaty, the European Patent Convention, and all other treaties of like purposes; and to publish cautionary notices reserving ownership of the inventions and all rights to register the Patents in appropriate registries. Assignor further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title and interest in Assignee.


