The undersigned, on behalf of Marvin Lumber and Cedar Company, a Minnesota corporation (the "Converting Organization"), for the purpose of converting the Converting Organization to a domestic Minnesota limited liability company, and pursuant to Sections 302A.682 to 302A.692 of the Minnesota Business Corporation Act ("MBCA"), hereby states as follows:

1. The name of the converting organization (as that term is defined in Section 302A.011, Subd. 64 of the MBCA) is Marvin Lumber and Cedar Company.
2. The name of the converted organization (as that term is defined in Section 302A.011, Subd. 63 of the MBCA) is Marvin Lumber and Cedar Company, LLC (the "Converted Organization").
3. The Converted Organization is a Minnesota limited liability company.
4. There are no other terms and conditions of the proposed conversion, other than the terms and conditions contained in this Plan of Conversion.




