2. Simon, Delavenne, Toft-Kehler and Sommer hereby confirm their belief that they are devisors of the invention.

3. In consideration of the sum of £1 now paid by the Assignee to each of the Assignors (receipt of which the Assignors hereby acknowledge) the Assignors hereby assign absolutely to the Assignee and the Assignee accepts an assignment of the Assignors' entire right title and interest in and to the Invention and the Patent Application and the full and exclusive benefit thereof including:
 - a. without limitation their entire right to apply for be granted and hold patents for the Invention in or for any part of the world (including without limitation title to any and all future or further applications as well as any and all divisional and continuation applications) and the right to priority;
 - b. the right to recover and take all such proceedings as may be necessary for the recovery of damages or other forms of relief in respect of all infringements of the Invention and/or Patent Application whether committed before or after the date of this Agreement.
