

Further, I agree that I will without additional compensation perform the following: communicate to the Assignee or its representatives any facts known to us respecting the Invention, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, substitute, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said Assignee, make all rightful oaths, and, generally do everything possible to aid said Assignee, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and its territorial possessions in any and all foreign countries.
