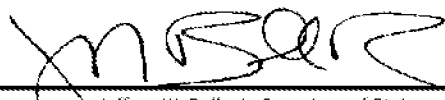

Pursuant to Section 251 of the  
General Corporation Law of the State of Delaware

Cohere Networks, Inc., a Delaware corporation ("*Cohere*"), does hereby certify to the following facts relating to the merger (the "*Merger*") of G. Ventures, Inc., a Delaware corporation ("*G.
