We hereby agree that the transfer of rights made by this instrument is effective as of the filing date of the application written above.



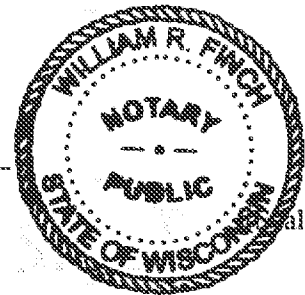
