By virtue of this Assignment, the Assignor has sold, assigned, and transferred, and by these presents does sell, assign, and transfer to the Assignee, the entire right, title, and interest for the United States in and to the inventions claimed in the Patent and the Patent itself; and any patents that may issue for said invention in the United States; together with the entire right, title, and interest in and to said invention and all patent applications and patents therefore in all countries foreign to the United States, including the full right to claim for any such application all benefits and priority rights under any applicable convention; together with the entire right, title, and interest in and to all continuations, divisions, renewals, and extensions of any of the patent applications and patents defined above; to have and to hold for the sole and exclusive use and benefit of the Assignee, its successors and assigns, to the full end of the term or terms for all such patents.

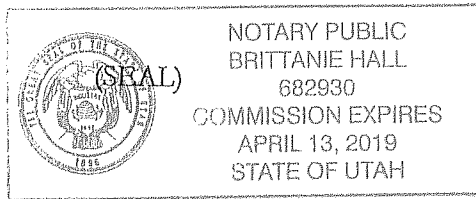
