**CERTIFICATE OF AMENDMENT OF CERTIFICATE OF INCORPORATION  
OF CAYMUS MEDICAL, INC.**

Caymus Medical, Inc. (the "Corporation"), a corporation organized and existing under the General Corporation Law of the State of Delaware, hereby certifies as follows:

1. This Certificate of Amendment (the "Certificate of Amendment") amends the provisions of the Corporation's Amended and Restated Certificate of Incorporation filed with the Secretary of State on July 15, 2013 (the "Certificate of Incorporation").

2. Article First of the Certificate of Incorporation is hereby amended and restated in its entirety as follows:

"FIRST. The name of the Corporation is Avenu Medical, Inc. (the "Corporation")."

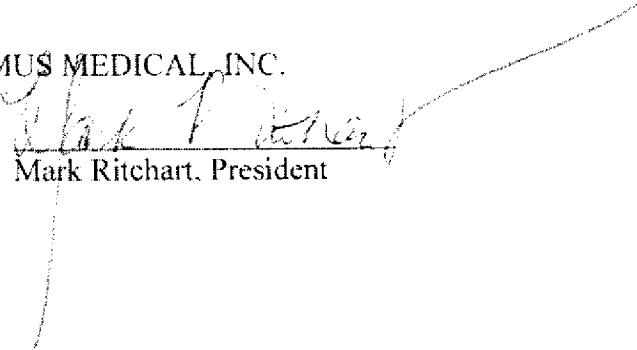
