AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith;

AND I HEREBY further covenant and agree that I will communicate to **THE RESEARCH FOUNDATION OF STATE UNIVERSITY OF NEW YORK**, its successors, legal representatives and assigns, any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid **THE RESEARCH FOUNDATION OF STATE UNIVERSITY OF NEW YORK**, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries;

AND HEREBY grant Heslin Rottenberg Farley & Mesiti, P.C., the power to insert on this assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document;

AND HEREBY, as the above named inventor, declare that the above identified application was made or authorized to be made by me.

AND HEREBY, as the above named inventor, declare that I believe that I am the original sole inventor of the claimed invention in the above identified application.

AND HEREBY state that I have reviewed and understand the contents of the above identified specification, including the claims.

AND HEREBY acknowledge the duty to disclose to the United States Patent and Trademark Office all information known to us to be material to patentability as defined in Title 37, Code of Federal Regulations, Section 1.56.


