2. FURTHER ASSURANCES.





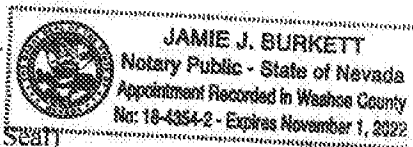
