
The Assignors hereby authorize and request the Commissioner of Patents and Trademarks to issue any said patent to Assignee.

cooperate to the best of the ability of the Assignors with Assignee, its successors and assigns, in any proceedings or transactions involving such applications or patents, including the preparation and execution of preliminary statements, giving and producing evidence, and performing any and all other acts necessary to obtain any said patents, both in United States and in foreign jurisdictions, and to vest all rights hereby conveyed in Assignee, its successors and assigns, whereby said patents will be held and enjoyed by Assignee, its successors and assigns, to the full end of the term for which said patents will be granted, as fully and entirely as the same would have been held and enjoyed by the Assignors if this assignment had not been made.


