Assignor represents and warrants that Assignor has the right, title, and authority to execute this Assignment and to convey any and all right, title, and interest in the Patent Rights, and that Assignor has not conveyed nor will convey hereafter all or part of the Patent Rights to a third party;


Assignor hereby authorizes said Assignee, its successors, and assigns, or anyone it may properly designate, to apply for Letters Patent in any and all foreign countries designated in the International application and regions, in its own name if desired, and additionally to claim priority to the filing date of the International application and otherwise take advantage of the provisions of any International conventions.

Assignor authorizes and requests any official of any State (Country) whose duty consists of issuing patents, or other evidence or forms of any industrial property protection on any aforesaid application, to issue same to Assignee, its successors and assigns, in accordance herewith;


