



On March 10, 2015 (the "PMBS Patent").

WHEREAS, on March 10, 2015, PMBS also filed a Patent Cooperation Treaty Application No. PCT/US2015/019771 entitled Mobile Sterilization Apparatus and Method for Using the Same, which ultimately published on October 8, 2015 as WO2015153084 and was nationally filed in Australia, Brazil, Canada, China, the European Patent Organization, Honk Kong, Kapan, South Korea, and South Africa (the collective of such filings being the "PMBS PCT Application") and on March 10, 2014 and September 22, 2014 PMBS also respectively filed provisional applications 61/950,502 and 62/053,338 (the "PMBS Provisionals").
