PATENT ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, **ASSIGNOR** hereby acknowledges that **ASSIGNOR** hereby assigns, conveys, and transfers unto **ASSIGNEE**, its successors, its legal representatives, and its assigns, the joint title and undivided one-half interest throughout the world in and to said **INVENTION**, including all patent applications therefor that may have been filed or may be filed hereafter for said **INVENTION** in the United States, including but not limited to U.S. Application No. 10/516,850 filed June 23, 2005, now Patent No. 7,665,148, issued on February 23, 2010, and all non-provisional applications relating thereto, (and do hereby authorize **ASSIGNEE** and its representative to hereafter add herein such application number(s) and/or filing date(s) when known), and all divisional applications, renewal applications, continuation applications, continuation-in-part applications, and design applications thereof, and all issued patents of the United States which may have granted or may be granted hereafter thereon and all reissues, renewals, reexaminations, and extensions to any of the foregoing and all patents issuing thereon in the United States;

AND **ASSIGNOR** further acknowledges and agrees that **ASSIGNOR** hereby assigns, conveys, and transfers unto **ASSIGNEE**, its successors, its legal representatives, and its assigns, all rights of priority under International Conventions, Treaties, or Agreements, and the joint title and undivided one-half interest throughout the world in said **INVENTION**, including all inventions related thereto or thereof, and all patent applications therefor that may have been filed or may be filed hereafter for said **INVENTION** in any foreign country, countries, or treaty/union organizations, and all divisional applications, renewal applications, continuation applications, continuation-in-part applications, patent of addition applications, confirmation applications, validation applications, utility model applications, and design applications thereof, and all issued patents which may have granted or may be granted hereafter for said **INVENTION** in any country or countries foreign to the United States, and all reissues, renewals, reexaminations, and extensions thereof;

ASSIGNOR hereby authorizes and requests the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications or registrations, to issue all patents for said INVENTION to said ASSIGNEE, its successors, its legal representatives and its assigns, in accordance with the terms of this instrument;

ASSIGNOR hereby assigns, transfers, and conveys to ASSIGNEE, its successors, its legal representatives, and its assigns all claims for damages and all remedies arising out of or relating to any violation(s) of any of the rights assigned hereby that have or may have accrued prior to the date of assignment to said ASSIGNEE, or may accrue hereafter, including, but not limited to the right to sue for, seek, obtain, collect, recover, and retain damages and any ongoing or prospective royalties to which ASSIGNOR may be entitled, or that ASSIGNOR may collect for any infringement or from any settlement or agreement related to any of said patents before or after issuance;

ASSIGNOR hereby covenants and agrees that ASSIGNOR will communicate promptly to said ASSIGNEE, its successors, its legal representatives, and its assigns, any facts known to us respecting said INVENTION, and will testify in any legal proceeding, sign all lawful papers, execute all applications and certificates, make all rightful declarations and/or oaths, and provide all lawful assistance to said ASSIGNEE, its successors, its legal representatives and its assigns, to obtain and enforce patent protection for said INVENTION in all countries;

AND ASSIGNOR hereby covenants that ASSIGNOR will not execute any writing or do any act whatsoever conflicting with these presents.
