ASSIGNMENT

WHEREAS, we, **Sumit Bhaduri, Frances H. DeBenedictis and D.V. NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00) and for other good and valuable consideration, the receipt of which is hereby acknowledged, we hereby sell, assign, transfer and set over to **Baker Hughes, a GE company, LLC**, all right, title and interest in and to the said inventions throughout the world, including said Applications and any and all divisions, continuations, reexaminations and reissues thereof, and any and all applications filed outside of the U.S. which claim priority to or the benefit of either or both Applications as well as all patents of the United States and foreign countries which may be granted therefrom including any reissues, divisionals, continuations, renewals and extensions and the like (collectively, the “Patents”), the same to be held and enjoyed by **Baker Hughes, a GE company, LLC** for its own use and benefit, and for the use and benefit of its successors, assigns, or other legal representatives, to the end of the term or terms for which said Patents of the United States or foreign countries are or may be granted or reissued, as fully and entirely as the same would have been held and enjoyed by us if this assignment and sale had not been made.


And we hereby authorize and request the Commissioner of Patents and other authorities in foreign countries to issue any and all patents on said inventions or resulting from said Applications and from any and all divisionals, continuations, reissues, reexaminations, renewals, and extensions thereof, to **Baker Hughes, a GE company, LLC**, as assignee of our entire interest, and hereby covenant that we have the full right to convey the entire interest herein assigned, and that we have not executed and will not execute any agreement in conflict herewith.

And we further hereby covenant and agree that we will, at any time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title of said inventions and to such patents as may be granted therefor, to **Baker Hughes, a GE company, LLC**, its successors, assigns, or other legal representatives and that if **Baker Hughes, a GE company, LLC**, its successors, assigns or other legal representatives shall desire to file any divisional or continuation, or to secure a reissue, or reexamination of such patents, or to file

a disclaimer relating thereto, will upon request, sign all papers, make all rightful oaths and do all lawful acts requisite for the filing of such divisional or continuation applications, or such application for reissue or reexamination and the procuring thereof, and for the filing of such disclaimer, without further compensation but at the expense of said assignee, its successors, or other legal representatives.

And we do further covenant and agree that we will, at any time upon request, communicate to **Baker Hughes, a GE company, LLC**, its successors, assigns or other legal representatives, such facts relating to said inventions and patents or the file history thereof as may be known to me, and testify as to the same in any litigation or administrative proceeding when requested so to do, without further compensation but at the expense of said assignee, its successors, or other legal representatives.


