I hereby acknowledge that this assignment being of my entire right, title and interest in and to said Applications, carries with it the right in Assignee to apply for and obtain from competent authorities in countries of the world any and all patents by attorneys and agents of Assignee's selection and the right to procure the grant of all such patents to Assignee for its own name as assignee of the entire right, title and interest therein;

AND, I hereby further agree for myself and my executors and administrators to execute upon request any other lawful documents and likewise to perform any other lawful acts which may be deemed necessary to secure fully the aforesaid Applications and patents to said Assignee, its successors, assigns and legal representatives, including the execution of applications for


