ASSIGNMENT

WHEREAS, we, Terje Strand, of San Francisco, California, and Brian Anderson, of Vancouver, B.C., Canada, have invented a certain invention, as described in the following patent application:

We confirm that, at the time the invention was made, we were under an obligation to

assign the invention to Expeto Wireless Inc.
