ASSIGNMENT FROM INVENTOR

WHEREAS **MILLER, Miller B.** of 33083 Myrtle Avenue, Mission, British Columbia, V2V 4R6, Canada ("INVENTOR") has made certain new and useful developments in the field of electrical power conditioning, which are described and claimed in a Patent Application entitled

which was filed in Canada on 22 February 2018 and received the patent application No. 2,995,969 before becoming the priority application for the Patent Cooperation Treaty (PCT) international application number PCT/CA2019/050178 having the international filing date of 13 February 2019 and the same title, thereafter being expected to be filed in the United States during the month of August, 2020 as a national phase entry application to that PCT international application, and has developed features and improvements thereof, whether or not reflected in the said Patent Application, (the "Invention").

INVENTOR hereby authorizes and requests issuance of any and all Letters Patents, when granted anywhere in the world, to the ASSIGNEE as assignee of the entire right, title and interest in and to the same, for the sole use and benefit of the ASSIGNEE, its successors, assigns, nominees or legal representatives, to the full end of the term or terms for which said Letters Patents may be granted, reissued or extended as fully and as entirely as INVENTOR would have held had this Assignment and sale not been made.

TO EVIDENCE THEIR AGREEMENT to the foregoing, each of the parties has executed this Assignment on the dates written herein below.


