ASSIGNOR further agrees without any payment by ASSIGNEE, other than expenses incurred by ASSIGNOR, to communicate to ASSIGNEE, its representatives or agents, facts relating to said inventions, including evidence for postgrant opposition purposes or for other proceedings, whenever requested; to testify in any postgrant opposition or other proceedings, whenever requested; and to execute and deliver on request all lawful papers required to make any of the foregoing provisions effective, and likewise make these provisions binding upon any heirs, legal representatives, administrators and assignees, and ASSIGNOR hereby warrants that, at the time of execution and delivery of this instrument, it is the lawful owner of the entire right, title and interest in and to said inventions and said Patents, and that the same are unencumbered and that it has good and full right and lawful authority to sell and convey the same in the manner herein set forth.
