- (d) causes of action and enforcement rights of any kind under, or on account of, any of the Patents and/or any of the items described in either of the foregoing categories (b) or (c), including, without limitation, all causes of action, enforcement rights and all other rights to seek and obtain any other remedies of any kind for past, current and future infringement.

As sole consideration for the Assigned Patent Rights, the Assignor shall be entitled to receive 10,000 ordinary shares, per value of 0.01 NIS of the Assignee, which constituted 100% of the Assignee issued share capital.

Assignor hereby authorizes the respective patent office or governmental agency in each jurisdiction to make available to Assignee all records regarding the Patents.

The terms and conditions of this Assignment of Patent Rights in the Assigned Patent Rights will inure to the benefit of Assignee, its successors, assigns, and other legal representatives and will be binding upon Assignor, its successors, assigns, and other legal representatives.
