Further, I will communicate to KDR Creative, LLC any facts known to me respecting the invention, and testify in any legal proceedings, sign all lawful papers, make all rightful oaths, and generally do everything possible to aid KDR Creative, LLC, its successors and assigns, to obtain and enforce proper protection of the invention and Patent Rights in the United States and its territorial possessions, and in any and all foreign countries.
