

2. The resulting converted entity will be a limited liability company governed by Louisiana Revised Statutes Title 12, Chapter 22.
3. The converting entity is continuing its existence in the organizational form of the converted entity.
4. The shareholder in the converting entity will be the member in the converted entity and the shareholder shall receive all of the membership interest in the converted entity.
5. The conversion has been authorized and approved in accordance with Title 12:1601, et seq.
6. The effective date of the conversion shall be 6:00 p.m., June 26, 2014.
7. The Articles of Organization of the converted entity are as follows:

**ARTICLES OF ORGANIZATION  
OF

**Article I  
Name**

The name of this limited liability company (hereinafter the "Company") shall be Coastal Cargo Company, L.L.C.

**Article II**  
**Duration**

This Company shall be in existence for a term beginning with the date this Company is formed and ending ninety-nine (99) years thereafter, unless continued prior to such date by Members collectively owning more than fifty (50%) percent of the Total Percentage Interest.

**Article III**  
**Purpose**

The purpose of the Company is to engage in any lawful activity for which limited liability companies may be formed under the Limited Liability Company Law of Louisiana.

**Article IV**  
**Management**

The Company shall be managed by Manager(s). Unless and until otherwise provided in the Operating Agreement, all of the business and affairs of the Company shall be managed by Managers of not less than one (1) nor more than five (5) Managers. The number of Managers may be increased or decreased within the limits above provided by a majority vote of the Members.

A Manager need not be a member of this Limited Liability Company.

Persons dealing with the Company may rely upon a certificate of any one of the certifying officials listed below to establish the membership of any member, the authenticity of any records of the Company, including without limitation, the Operating Agreement, or the authority of any person to act on behalf of the Company, including, without limitation, the authority to take the actions referred to in La. Rev. Stat. Section 12:1318(B). The following persons are hereby named authorized

certified officials of the Company, and any one of them may exercise the full authority granted by La. Rev. Stat. Section 12:1305(C)(5) without the need to obtain the written approval or certification of any other certified official: Daniel L. Haeuser and/or Elisa Azze.
