CORPORATE NAME**

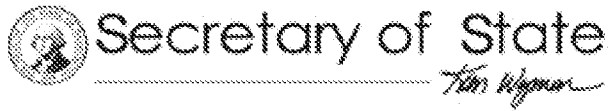
The name of the corporation is BetterLife Pharma US Inc. (the "Corporation")
