


said Letters Patent or any legal equivalent thereof to said ASSIGNEE, its successors and assigns, in accordance with this Assignment.


ASSIGNOR, and each of them, hereby covenants no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Agreement;


