




**"A REVERBERATING PERCUSSION INSTRUMENT"**

communicate to said Assignee or its representatives all facts known to the undersigned with respect  
to said patents / applications, whenever requested, to testify in any legal proceedings in which the  
said patent applications may become involved, to sign all lawful papers, make all rightful oaths, and  
to do generally everything necessary to aid said Assignee, its successors, assigns and nominees to  
register the assignment of the said Patent Applications, the expenses incident to said applications to
