Pursuant to the provisions of Section 14-11-904 of the Official Code of Georgia Annotated (the "OCGA"), the undersigned, on behalf of the limited liability companies set forth below, hereby executes and delivers the following Articles of Merger setting forth:

I.

The names and jurisdictions of formation of the constituent business entity that is merging and of the surviving business entity into which the constituent business entity is merging are, respectively, as follows:

Baking Technology Systems, LLC, a Georgia limited liability company (the "Merged Company"); and

AMF Automation Technologies, LLC, a Virginia limited liability company (the "Surviving Company").

II.
