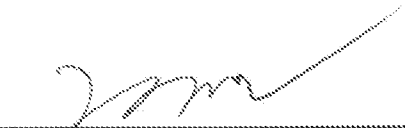

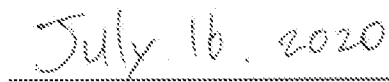
any of the improvements; and in and to all original and reissued patents which have been or shall be filed in the United States and all foreign countries on the improvements.
