## ASSIGNMENT



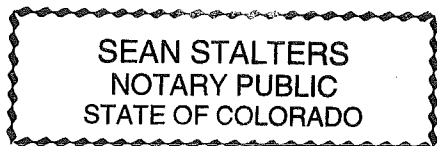
