## RELEASE OF SECURITY INTEREST

**THIS RELEASE OF SECURITY INTEREST** is made effective September 4, 2020, by the undersigned Lenders (as defined below) in favor of Grantors (as defined below). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Collateral Agreement or the Security Grants (as defined below), as applicable.

### W I T N E S S E T H

**WHEREAS**, Callisto Media Inc., a Delaware corporation ("**Borrower**"), have entered into (i) that certain Loan and Security Agreement, dated as of December 27, 2016 (as amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "**2016 Loan Agreement**"), between Borrower, Venture Lending & Leasing VII, Inc. ("**VLL7**"), and Venture Lending & Leasing VIII, Inc. ("**VLL8**", and together with VLL7, collectively, the "**2016 Lenders**"), (ii) that certain Loan and Security Agreement, dated as of January 19, 2018 (as amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "**2018 Loan Agreement**"), between VLL8 (the "**2018 Lender**") and Borrower and (iii) that certain Loan and Security Agreement, dated as of February 19, 2019 (as amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "**2019 Loan Agreement**" and together with the 2016 Loan Agreement and 2018 Loan Agreement, each a "**Loan Agreement**" and collectively, the "**Loan Agreements**"), between Borrower, VLL8 and Venture Lending & Leasing IX, Inc. ("**VLL9**" and together with VLL8, collectively, the "**2019 Lender**", and together with the 2016 Lenders and 2018 Lenders, each a "**Lender**" and collectively, the "**Lenders**") (as amended, restated, supplemented or otherwise modified from time to time, the "**Security Agreements**"), which required Grantors to enter into the Security Grants (defined below);

**WHEREAS**, Borrower and Pas Mal LLC, a Delaware limited liability company (collectively with Borrower, "**Grantors**"), have entered into (i) that certain Intellectual Property Security Agreement, dated August 3, 2015, Amended and Restated Grant of Trademark Security Interest, dated October 25, 2016, Consent and Reaffirmation of Collateral Agreement, dated August 12, 2019, Grant of Trademark Security Interest, dated August 12, 2019, Grant of Patent Security Interest, dated August 3, 2015, Amended and Restated Grant of Patent Security Interest, dated October 25, 2016, and Consent and Reaffirmation of Collateral Agreement, dated August 12, 2019 (collectively, the "**Security Grants**"), under which Grantors granted to Lender a security interest in all of Grantors' right, title, and interest in and to the Trademark Collateral and Patent Collateral, including the intellectual property listed on Schedule 1 hereto;

**WHEREAS**, the debt, lien and/or other liability as set forth and discussed in the Security Grants has been repaid in exchange for Lender's termination of the Security Grants and release of the security interests in all Trademark Collateral and Patent Collateral;


**NOW, THEREFORE**, in exchange for good and valuable consideration, receipt of which is hereby acknowledged, Lender agrees as follows:

Lender hereby (i) releases, waives, resigns and disclaims any and all security interests and liens Lender may have in, to or under the Trademark Collateral and/or the Patent Collateral, including any of the intellectual property listed on Schedule 1 hereto, (ii) terminates the Security Grants, and (iii) re-assigns to Grantors, any right, title or interest Lender may have in, to or under the Trademark Collateral and the Patent Collateral, together with the goodwill of the business symbolized thereby.




