AND I hereby covenant that I have full right to convey the entire interest herein assigned, and that I have not executed and will not execute any agreement in conflict herewith.

AND I further covenant and agree, in respect of said application(s), Invention, Letters Patent, patents, and any and all patent applications filed or to be filed on or in relation wholly or partly to said Invention in any country or patent organization, and any and all patents which may issue thereon, and any and all reissues, reexaminations, pipelines, extensions, supplementary protection certificates, and governmental exclusivity rights extending therefrom, that at Assignee's expense, I will each time a request is made and without undue delay: (i) execute and deliver all such papers as may be necessary or desirable to perfect title to Assignee, its successors, assigns, or legal representatives; (ii) communicate to Assignee or to its nominee all known facts; (iii) testify

in any administrative or legal proceedings, including any interference, arbitration, opposition, reexamination, inter partes review, post grant review, or litigation; (iv) execute and deliver all lawful papers and documents, including all petitions, specifications, affidavits, declarations, and disclaimers; (v) furnish Assignee with any and all documents, photographs, models, samples, and other physical exhibits in my/our control or in the control of my/our heirs, legal representatives, or assigns, and (vi) make all rightful oaths, and generally to do everything possible to aid Assignee, its successors, assigns, and legal representatives to obtain, maintain, and enforce for its or their own benefit proper patent protection for said Invention or any part of it in any and all countries.

AND I hereby authorize and request the Commissioner of Patents and Trademarks of the United States and any official of any country or countries foreign to the United States whose duty it is to issue patents on applications as aforesaid, to issue to said Assignee, as assignee of the entire right, title and interest, any and all applications and Letters Patent for said Invention or any part of it, including any and all Letters Patent of the United States which may be issued and granted on or as a result of the application(s) aforesaid, in accordance with the terms of this assignment.


