RELEASE OF PATENT SECURITY INTEREST

This RELEASE OF PATENT SECURITY INTEREST ("Release") is made and effective as of September 14, 2020 and granted by LBC CREDIT AGENCY SERVICES, LLC in its capacity as agent for the Lenders (the "Collateral Agent"), a Delaware limited liability company having an address of 2929 Arch Street, Suite 1550 c/o LBC Credit Partners, Inc., Cira Centre Philadelphia, Pennsylvania 19104-7340, as collateral agent for the secured parties under the Loan Agreement referred to below (the "Secured Parties"), in favor of PLEWS INC. a Delaware corporation having an address of 1550 Franklin Grove Road, Dixon Illinois 61021 (the "Grantor"). Terms not otherwise defined herein shall have the meaning ascribed to them in the Patent Security Agreement.

WHEREAS, pursuant to that certain Term Loan and Security Agreement dated as of July 29, 2016 (as amended, restated, supplemented or otherwise modified from time to time, including all exhibits and schedules thereto, (the "Loan Agreement") among BASIL TREE HOLDINGS, LLC, a Delaware limited liability company ("Holdings"), Grantor, the lenders from time to time party thereto (the "Lenders"), and Collateral Agent, the Grantor executed and delivered to the Collateral Agent that certain Patent Security Agreement by and between the Grantor and the Collateral Agent dated as of July 29, 2016 (the "Patent Security Agreement");

WHEREAS, pursuant to the Patent Security Agreement, Grantor pledged and granted to the Collateral Agent for the benefit of the Lenders, a continuing first priority security interest in all of such Grantor's right, title and interest in, to and under the Patent Collateral;

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") at Reel 039332, Frame 0847 on August 3, 2016; and

WHEREAS, the Grantor has requested that the Collateral Agent enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title and interest the Collateral Agent may have in the Patent Collateral pursuant to the Patent Security Agreement, including those patents and patent applications listed on Schedule 1.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby states as follows:

Release of Security Interest. Collateral Agent, on behalf of itself and the Secured Parties, their successors, legal representatives and assigns, hereby terminates the Patent Security Agreement and irrevocably terminates, releases and discharges any and all liens or security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Patent Security Agreement in the Patent Collateral, including all of its right, title and interest in, to and under the following:

- (a) all of Grantor's Patents and Licenses, including those referred to on Schedule A hereto;
- (b) all reissues, continuations, continuations-in-part, substitutes, extensions or renewals of and improvements on the foregoing; and


- (c) all products and proceeds of the foregoing, including any claim by such Grantor against third parties for past, present or future infringement or dilution of any Patent or any Patent licensed under any License.

Further Assurances. Collateral Agent agrees, at the Grantor's expense, to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release, including to (i) record this Release with the USPTO, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release and discharge of the security interest of Collateral Agent in the Patent Collateral and/or (iii) otherwise record or file this Release in the applicable governmental office or agency.
