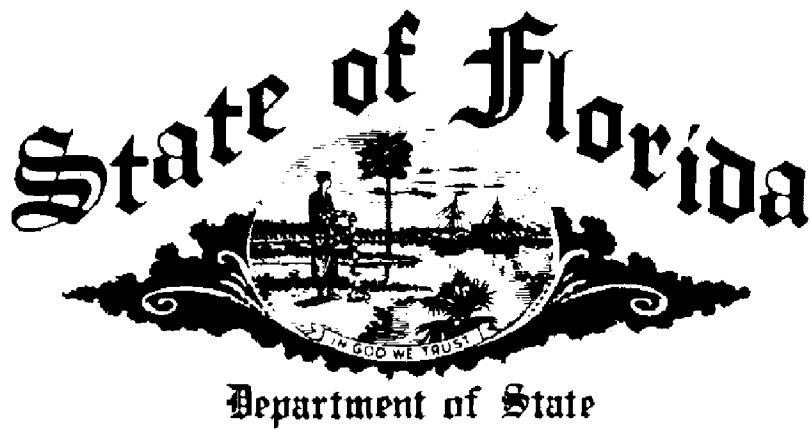

ARTICLE III - AMENDMENT


The following amendment to the Articles of Organization was duly adopted by the Company in conformance with the Operating Agreement of the Company and Florida law:
