AND We also agree that we will not engage, participate, or take part in any action conflicting with this Assignment, including but not limited to challenging the validity or patentability or enforceability of any patent rights relating to this invention or assisting others with such a challenge;

AND If any provision in this Assignment is held invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions shall not in any way be affected or impaired thereby;

AND We hereby grant the Assignee, its successors, legal representatives and assigns, the power to insert on this instrument any further identification that may be necessary or desirable to

comply with the recordation rules of any appropriate and competent authority, including, without limitation, the United States Patent and Trademark Office.


AND We hereby agree that this Assignment may be executed in two or more counterparts each of which shall be deemed an original but all of which together shall constitute one and the same instrument.
